## **IPEDS Categories**

## Why do we need IPEDS Categories?

The State Board submits financial aid information to IPEDS on behalf of the colleges each year. The Financial Aid Survey is part of the IPEDS Winter Collection Cycle. The aggregated number of students receiving financial aid and the amount disbursed must be reported by the predefined IPEDS Category. The source of the reporting is the SBCTC Data Warehouse.

### How are IPEDS Categories mapped to financial aid?

Enhancement request #137 was approved in the spring of 2022 and consisted of leveraging the Keyword1 data element in the Financial Aid module of ctcLink. Keyword1 was not being used and allows for designating a set of valid values. Keyword1 will represent the IPEDS Category and will be extracted for the SBCTC Data Warehouse where the reporting is generated.

The information in this document is intended to assist colleges with the assignment of an IPEDS Category to any new Financial Aid Item Types.

During the summer of 2023, Data Services staff worked with the ctcLink Support organization to do the initial assignment of IPEDS Categories using a bulk update SQL script. Once the original assignments are updated, all additional assignment of IPEDS Categories will be done at the time of the Item Type creation.

The initial association of IPEDS Categories was primarily based on the smart coding of the Item Type. See the <u>Financial Aid Item Type to IPEDS Keyword1 Mapping</u> section of this document for more detail.

# Financial Aid Category definitions obtained from the IPEDS Student Financial Aid Survey Instructions:

The following types of financial aid should be reported in this component:

**Federal grants (grants/educational assistance funds):** Grants provided by federal agencies such as the U.S. Department of Education, including Title IV federal student aid grants such as Pell grants, Federal Supplemental Educational Opportunity Grants (FSEOG), Academic Competitiveness Grants (ACG),National Science and Mathematics Access to Retain Talent (National SMART) Grants, and Teacher Education Assistance for College and Higher Education(TEACH) Grants. Also include need-based and merit-based educational assistance funds and training vouchers provided from other federal agencies and/or federally-sponsored educational benefits programs.

Do not include veterans education benefits, as defined in section 480(c) of the HEA, as they are no longer treated as Estimated Financial Assistance (EFA) for the Office of Federal Student Aid's purposes. **Federal loans to students:** Monies from the federal government that must be repaid for which the student is the designated borrower. This type of aid includes all Title IV federal student loan aid such as Federal Perkins Loans, Subsidized Direct or FFEL Stafford Loans, and Unsubsidized Direct or FFEL Stafford Loans. Do not include PLUS loans and other federal loans not made directly to the student.

**State/local government grants (grants/scholarships/waivers):** Grants that were awarded by your state such as Leveraging Educational Assistance Partnerships (LEAP) (formerly SSIGs) and Robert C. Byrd Honors Scholarships. Include merit-based grants or scholarships that were provided by your state or local government. Also include tuition and fee waivers for which your institution was reimbursed by a state or local government agency.

**Institutional grants or scholarships (scholarships/waivers):** Grants, scholarships, and fellowships granted and funded by the institution and/or individual departments within the institution and are limited to students attending your institution. Also include scholarships targeted to certain individuals(e.g., based on state of residence, major, or participation in athletic activities) for which the institution designates the recipient. Also include institutional tuition and fee waivers for which your institution was not reimbursed by a state or local government agency. This is not intended to include Federal Work Study.

**Private grants or scholarships:** Grants or scholarships to students that are awarded and paid by an outside organization but are directed through the institution's financial aid office (e.g., Rotary Club Scholarship).

**Private loans to students:** Monies that must be repaid to the lending institution for which the student is the designated borrower. Include all institutionally and privately sponsored loans. Do not include loans that are not made directly to the student.

#### What NOT to Include

#### Do not report:


- Federal Work Study amounts into any total aid amounts
- ROTC aid, which are excluded from EFA calculations, in any total aid amounts
- Loans that are made to someone other than the student
- Military/veterans aid in Section 1 because such aid is ONLY reported in Section 2
- Experimental Pell grant amounts

## Financial Aid Item Type to IPEDS Category Mapping Query

Query QCS\_FA\_IPEDS\_KEYWORD\_REV has been developed for colleges purpose to review the mapping of Financial Aid Item Types to assigned IPEDS Category and compare to the calculated IPEDS category. SBCTC asks that colleges verify their mapping by August each year in preparation for the year-end financial aid snapshot. Any Item Types that are not associated with an IPEDS Category will not be reported to IPEDS.

Reporting of this information selects the current effective dated row Active status for the selected Aid Year Financial Aid Item Type and the reporting attributes associated with it. The selection criteria used for IPEDS is listed and the same calculated IPEDS value is also included in the query.

## Financial Aid Item Types Excluded from IPEDS Reporting

Some ITEM\_TYPES are not included in the IPEDS reporting.

#### They include:

- ITEM\_TYPES mapped to "NOT\_RPT" IPEDS Category
- ITEM\_TYPES not mapped to an IPEDS Category

## Requesting an IPEDS Category assignment to Item Type

The <u>Item Type Request Form QRG</u> (quick reference guide) provides instruction for assigning an IPEDS Category to an Item Type.

If you are requesting a new Item Type, you will need to designate the appropriate IPEDS Category using the information in this manual.

Please use this same process if you are requesting a change to the IPEDS Category assignment.
