- MFA for student sign-on for Financial Aid deadline is January 31 or February 1, 2024
 - Dani mentioned ITC wants to remove the security questions
 - She would like to take this through the Enhancement Request process
 - Grant will send message out with the timelines and information

- Student Success Software
 - Presidents voted to move forward with RFP for single product selection
 - Motion didn't clarify there the requirement/obligation to purchase from an RFP
 - STAC needs to pick a single product
 - RFP need to identify the requirements and which ones will go in the RFP
 - Leverage existing contracts
 - We have to implement into system and it needs to meet security requirements
