- **Application Services:**

- **Environments/Activities** -Ray reported the following:
  - PeopleTools Upgrade to 8.59- Saturday, April 29. This impacts all pillars therefore downtime is 7:00AM – 8:00PM. Canvas will be available but users need to access directly as the ctcLink portal will not be an option. Communication for this downtime was sent out on the ctcLink Alerts listserv last Monday.
  - \*Partial Code Freeze is 3/14 to 4/29. This does not impact query migrations or sequel code, just code changes.
  - Work activity related to 8.59 upgrade:
    - PDV migration completed 3/14
    - PTS migration completed 3/22
    - PQA migration in-progress to be completed 4/19
  - PCD Refresh from PROD including 8.59 upgrade- Monday, May 1st. PCD will be down most of the day.
  - PeopleTools 8.59 SIT went from 3/28 through 4/13. Below are the results from morning of 4/18:
    - CS- 99% Passed (fix in place for issue and will be re-tested)
    - FIN 100% Passed
    - HCM 98% Passed (fix in place for issue and will be re-tested)

Biggest challenge thus far with 8.59 upgrade is related to Search bar functionality. It has been added to the top of the page; however, is not functioning as advertised and returns either unclear results or invalid URL navigation. Search bar can be configured as Standard Search or Suggestion Search. With Standard, results returned are somewhat of a random order and there appear to be duplicates in some cases. Also, users may see results but they don't have the navigation security. With Suggestion, it should display a list of the users most frequently accessed pages. This search seems to work most of the time but in some cases when trying to navigate to one of the result pages, users get invalid URL. Bottomline, neither of the options are acceptable therefore a ticket has been opened with Oracle. While waiting for the response, the technical team is working to troubleshoot to come up with a better solution. At this point, the recommended workaround is to configure

the Standard Search to display zero results, which mirrors 8.57 functionality. When you click Search bar and hit the magnifying glass or enter key, it will display 8.57 results.

- **Accessibility** -Christopher reported the following:
  - **Enter Time-**
    - On the Enter Time page, when switching between Elapsed time and Punch time jobs, the focus lands on the back button instead of staying where it should. Oracle agrees this is an issue and is working on a development solution.
  - **PeopleTools 8.59-**
    - In "My Preferences" you can add Screen Reader Mode to the Actions menu.
    - You can enable screen reader mode for one session or have it persist.
    - Increased Color contrast of file attachment drop area border.
    - Changes on Component Search Pages and Prompt Lookup Search Pages
    - When Search button is pressed and no matching values return, the text "no matching resulting were found" was not read by assistive technology and now it is.
    - Prior to Tools 8.59, the grid header button did not announce that it was a sort button. This issue is corrected in 8.59.
    - Prior to Tools 8.59, if user selected the ESC button on the keyboard it will close the grid action menu but doing so refreshed the page and the user was taken back to the top of the page. In Tools 8.59 ESC button closes the popup menu and the focus remains on the same action menu grid icon.
    - Prior to Tools 8.59, in Query Manager or Viewer page screen readers never read the criteria "begins with" even when user tabbed back. This issue is fixed in Tools 8.59. Criteria "begins with" is read along with the search field value.
- **Security:** Shelia reported the following:
  - **CS Pillar**
    - Advising Notes – Secure by Institution Released to PROD and the New Local Security Role grant roles in all pillars are in PROD as well.
    - Beginning development on new Report Definition roles by Institution.
    - Masking is ready to develop for second round but is on hold until some of the other priorities are farther along.
    - PeopleTools Testing
    - Item Type Security Testing
  - **FS Pillar**
    - Masking is ready to develop for First Round.
    - PeopleTools Testing
  - **HCM Pillar**
    - Masking is ready to develop for First Round
    - PeopleTools Testing
    - Automated offboarding (all pillars) - waiting on development resource.

## Mindful Minute (01:28 – 01:33mins)

- Beth and Pat shared that they discussed the *RTM* survey they created made up of items from all pillars deemed as *Requirement Clarifications Needed* to College Collaboration Group last Wednesday, April 12. These surveys were sent out to the members late Monday, April 17, to give a once-over and provide feedback rather than bring 1, 2 or 3 at a time to Working Group, for efficiency purposes. This gives the colleges an opportunity to highlight any items that jump out to them as needing more conversation before being moved forward to a future De-Scope vote. They are not asked to provide those thoughts at the time of survey submission, just identify those that jump out at them. The survey is broken into couple week segments so colleges can gather SMEs to have the conversations or move through them in the way that is most conducive for sufficient feedback. Colleges have until the end of July to get through entire list. Those highlighted items will then be brought to the State Board to engage with the colleges to get more needed information in order to make a better-informed decision on whether an Enhancement Request is needed to keep it moving or whether it can be moved to De-Scope vote at a future Working Group meeting.
