## BEdA ER Update - William Durden (01:21 - 01:38)

- BEdA High Level Overview
- ctcLink History and BEdA Grading Basis
  - Generates FTEs
  - Suppresses grades from impacting Financial Aid SAP
  - Suppresses BEdA courses from counting toward Financial Aid Pace Calculations
- Enhancement Request: BEdA Grading Basis 2.0
  - Produce an official transcript that conforms to the requirements of RCW
     28A.230.125 (requires standardized high school transcript) and WAC 392-415-070 (describes the mandatory components)
  - Find a way to include GPA and credits earned in the Academic Advising Report (while still suppressing information from financial aid considerations)
  - o Include automated pre-requisite and "three-peat" checking
- \*\*\*Please listen to recording for discussion:
  - Options brought up by Jill, such as putting them in their own career as they would have their own rule set.
  - Encouraged to bring to CCG to get input from schools for more information gathering for a comprehensive ER submitted.
  - As long as the ER clearly states the problems to be addressed, the internal teams would be able to analyze from there.
  - o Communication and information will continue, and all will be kept abreast of status.

BEdA Grading Basis 2point0 ER Presentation

Mindful Minute (01:40 - 01:49 min) \*ER 248 presented 01:38-01:40

• Beth mentioned having a long open discussion the last hour of College Collaboration Group last week for people to share what they have heard or rumors or what are the things you have maybe heard and don't know about.

Initially opened it up based on recent decision by presidents to move forward with an RFP for a Student Success package. Some questions from that:

- Is there an opt in or opt out option if we were to agree as a system to move forward with a tool?
- o How would the RFP be developed?
- o Who would be involved?
- O What would the timeline look like?

STAC has said they are preparing a fact sheet on what was discussed and what some of those possible were or still to be decided on. More information to come.

- Beth also mentioned rumor of "end of life" of Oracle. There is a 10-year warning as the goal is to be moving to the Cloud. Colleges or systems would make a decision on how to proceed at that point. It is nothing that is going to be dropped in our laps in the next year or two.
- Beth mentioned outside vendor or a consultant come in to make recommendations to improve Financial Aid set up in ctcLink. It's not to change the enhancements we have come up with, but to help colleges adapt to doing processes in a more uniform way across the system.
- Lastly, Beth mentioned most discussion was around MFA for students and the deadline, which was stated in STAC to be January 31st or February 1st...whichever date you preferred.
  - Discussion about how to go about it
  - o Jason shared how they have gone about it and shared documentation with the group
  - How to automate it
  - Shelia clarified how it would happen as colleges would send a list to her team and they would
    do a mass assignment and then new students would be automatically assigned subsequently.
  - Bellevue shared they are planning to go live end of November/beginning December with current and past students. Led to discussion around Bellevue being such a large institution and impacts to colleges along I-5 corridor.
    - Shelia shared November 15<sup>th</sup>, they are doing 72,000 students, which a good portion are alumni. Have been working with LW tech and other colleges that have concerns about this and security is juggling the effort as a balance for the system to make sure we aren't stepping on each others toes. Cautioned based on all factors.
      - The dynamic criteria is basically if the student is enrolled at your college and in class for that term, they get the MFA role.
      - If they are outside that criteria, security is doing mass loads as requested- with the
        disclaimer and caution to those schools going live to be mindful of those that haven't
        implemented.
  - Questions about implementing:
    - Would email still be an option?
    - Would it only be phones? What if the student doesn't have a phone?
    - The security question not being an option any longer for staff or for students?
- Pat mentioned Highline getting a note from Nelnet asking if MFA had been implemented for students.
   A date of November 28<sup>th</sup> was given by Nelnet as they will be implementing theirs. Opt in deadline is November 15<sup>th</sup>.
