Project Description:

The Library Renovation project will be a comprehensive renovation of 58,177 square feet of the existing Library Building to extend the life of the building for the next 50 years. The work will include upgrades to the structural systems to meet life safety code requirements for resisting seismic forces, replacing mechanical and electrical systems to meet functional and energy code requirements and infrastructure renewal and building renovation to accommodate contemporary classrooms, informal study spaces, and active learning environments. The project will create an Information Commons that supports contemporary library services and to include E-Learning, the Teaching and Learning Center, the Student Media Center and a Print Media Space.

Project Status:

The project did not meet its original completion date in May of 2023 due in part of contractor scheduling related sub-trades and a combination of latent and market conditions. The project achieved substantial completion May 10, 2024. Construction allocation including contingency is reaching its limit with some remaining closeout costs still to be finalized. The owner is awaiting final costs from contractor to navigate any additional funding required to cover.
