## **Guided Pathways and ASAP Matrix**



In 2019, the Washington State Legislature passed the Workforce Education Investment Act, providing funding to all 34 community and technical colleges to implement Guided Pathways, a framework designed to create structured support for students from enrollment to completion. In 2023, Washington received a planning grant to explore the Accelerated Study in Associate Programs (ASAP)<sup>1</sup>, which offers intensive support to full-time students to accelerate completion. While ASAP shares some similarities with Guided Pathways, Washington is not adopting ASAP as a statewide model.

This document compares key elements of Guided Pathways and ASAP.
